- That proper record of cash books, ledgers, Assetts created complete address of beneficiaries and other relevant record is maintained at all levels for check of any visiting team from Central/ State Government.
- 5. The account of the District Health Society shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI. Whenever the society is called
- That the above sanctioned funds are immediately transferred to Block Medical Officers within 2 days through e-transfer under intimation to the State Health Society except in some cases where e- transfer facility is not available and also ensure that funds are got released by BMOs to downwards.
