(a) National Programme for Prevention & Control of Diabetes, Cardiovascular Diseases & Stroke (NPCDCS) (b) National Programme for Cancer and (c) National Programme for Health Care of Elderly (NPHCE) in the district.
2. That a separate assets register for the programme is maintained at the level of each facility under seal & signatures of the Head of the institution.
3. That all purchases of equipments required be procured are effected from the valid and approved rate contract of the concerned purchase committee of the department.
4. That the funds are utilized after observing all legal formalities required under rules and guidelines of MOH&FW, GoI which is available on the website i.e. www.jknhm.com and www.jkhealth.org.
5. That monthly Statement of Expenditure and Utilization Certificate is sent to the SHS regularly.
6. The account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Officer of the Ministry of the Health & Family Welfare, GoI. Whenever the society is called upon to do so.
