- 4. That proper record of Cash Books, Ledgers, Assels created, complete address of beneficiaries and other relevant records is maintained at all levels for check of any visiting team from Central/State Government.
- The account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comprotter and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the ministry of Health & Family Welfare, Government of India, whenever the society
- 6. That the above sanctioned funds are immediately transferred to Block Medical Officers within 2 days through Etransfer under intimation to the state Health Society except some cases where E-transfer facility is not available and ensure funds are got released by BMOs to downwards.
