**Sir,**

Sanction is hereby accorded to the release of **Rs.128.90 Lacs** (Rupees One Crore Twenty Eight Lacs Ninety Thousand only) (Rs.65.10 Lacs for DHS Kupwara and Rs. 63.80 Lacs for DHS Poonch) as Grant-in-Aid under Base Flexi pool for the activities to be undertaken during the year 2012-13.

Accordingly the above sanction GIA is transferred to the Bank A/C No.SBG-85 of J&K Bank Ltd, Kupwara and A/C No.SG-21759 of J&K Bank Ltd. Poonch under the head Base Flexi pool.

**The Grant-in-Aid is subject to the following conditions:**

1. That the funds sanctioned are utilized strictly as per the Budget Sheets and the guidelines issued by the State Health Society from time to time that too after observing all codal formalities.
2. That District Health Society shall follow all the financial management system under NRHM and shall submit monthly FMR, Quarterly Summary of Concurrent Audit and monthly statement of funds position as per formats already provided.
3. That the physical achievements are sent to State Health Society regularly.
4. That proper record of Cash Books, Ledgers, Assets created, complete address of beneficiaries and other relevant records is maintained at all levels for check of any visiting team from Central/State Government.
5. The account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the ministry of Health & Family Welfare, Government of India, whenever the society is called upon to do so.
6. That the above sanctioned funds are immediately transferred to Block Medical Officer within 2 days through e-transfer under intimation to the State Health Society except in some cases where e-transfer facility is not available and also ensure that funds are got released by BMO's to downwards.
