That the Physical/Financial achievements are to be sent to the State Health 6.

That the monthly Statement of Expenditure and Utilization certificate are to be 7.

sent to the State Health Society regularly.

That the funds shall be utilized to fill up the gaps to deal with COVID-19 8. pandemic and also ensure that there may not be duplication of similar activities from other source.

That the proper record of Bank Column Cash Book, Ledger, Assets Register and 9. other relevant records are to be maintained for inspection of any visiting team

from Central/State Government.
