Sub: Release of Grants-in-Aid under India COVID-19 Emergency Response and Health System Strengthening Preparedness Package for engagement of manpower (Temporary) on out-sourcing basis for data entry operations for COVID-19 related works under NHM, J&K.(FMR Code:B.31.4)

Madam/ Sir,

As per the approval conveyed by the Ministry of Health & Family Welfare, GoI under India COVID-19 Emergency Response and Health System Strengthening Preparedness Package, sanction is hereby accorded for release of Grants-in-Aid **Rs.5,02,860/- (Rupees Five Lac Two Thousand Eight Hundred and Sixty only)** for engagement of manpower (temporary) on out-sourcing basis for data entry operations on the portals of COVID-19 related data at below mentioned Health Institutions/District Hospitals under NHM, J&K.



The Grants-in-Aid sanctioned is subject to following terms & conditions:

1. That the funds shall be utilized towards manpower engaged for data entry operations on portals maintaining for COVID-19 related data at Tertiary Care/District Hospitals, after observing all codal formalities required under rules and according to the guidelines issued by the Ministry of Health & Family Welfare, Govt. of India for COVID-19.
2. That the State Health Society will release funds on PFMS portal and the same shall be accepted after confirming receipt of funds from your bank. Subsequent transfer/utilization of these funds shall be preferably through PFMS portal.
3. That these funds shall be immediately transferred to concerned Drawing & Disbursing Officers (DDOs) to timely clear the Invoices of out-sourcing Agency of such manpower. Concerned DDOs, alongwith Controlling Officers, shall also ensure timely and regular data entry operations on portals of COVID-19.
4. That in view of process initiated by State Health Society, NHM, J&K for relocation/rationalization of manpower already engaged for data entry operations in various healthcare facilities.
5. No manpower for data entry operations or any other Programme/Scheme under NHM, shall be hired by Districts/ Implementing Agencies at its own;
6. Any vacancy arising due to resignation of manpower presently engaged for data entry operations under any Programme/Scheme of NHM, be filled up only in consultation with the State Health Society, NHM, J&K; and
7. In exceptional cases, wherever required, Districts/Implementing Agencies shall submit its requirements with respect to any manpower for data entry operations relating to the Programmes/Schemes of NHM, alongwith substantiating justifications including, manpower already engaged for data entry operations, workload, etc. to the State Health Society, NHM, J&K for appropriate necessary action.
8. *That the Optimum utilization of funds shall be ensured alongwith avoidance of unnecessary parking of funds. Further funds will be released after receipt of Statement of Expenditure/Utilization Certificate by the State Health Society before 5th of next month.*
9. That the proper record of Cash Book, Ledger, Asset Register and other records be maintained under seal & signatures of the concerned officers and shall be made available for checking by any of the visiting team from Central/ State Govt.
10. That the accounts of Implementing Agencies/ District Health Societies shall be open to the inspection by the sanctioning authority and audit both by the Comptroller & Auditor General of India under the provisions of CAG (DPC) Act, 1971 and Internal Audit by the Principal Accounts Officer of the Ministry of Health & Family Welfare, Govt. of India, whenever called upon to do so.
