Sir,

As per the approval conveyed by the Ministry of Health & Family Welfare, Govt. of India and subsequently approved by the Chairman, Executive Committee, State Health Society, NHM. J&K, sanction is hereby accorded to release of Grants-in-Aid of Rs.50.00 Lac (Rupees Fifty Lac Only) under RCH Flexible Pool for Routine Immunization and Family Planning activities conveyed in the Budget Sheet for the financial year 2020-21. Further funds shall be released only after receipt of Utilization Certficate alongwith physical achievements as per the conditionalties DoE conveyed by the MoH&FW, GoI.

The Grant-in-Aid released is subject to following conditions:

- That the above sanctioned funds are to be utilized for all approved activities of RCH Flexible Pool including Routine Immunization & other activities of Family Planning strictly as per Budget Sheet for the FY:2020-21 has already been shared with your office vide SHS/J&K/NHM/FMG/5292-5306 dated 06/07/2020 and guidelines of MoH&FW. Gol after observing all codal formalities required under rules.
- That no diversion of funds is permissible without approval of the Competent Authority.
- That all the payments/expenditure are to be done only through e-transfer (no cash payments).
- 4. That the monthly Statement of Expenditure (SOE) and Utilization Certificate (UC) in GFR 19A are to be sent to State Health Society regularly.

5. That the proper record of Bank Column Cash Books, Ledgers, Assets Register and other relevant records is maintained for inspection of any visiting team from Central/State Government.

6. That the account of the grantee shall be open to inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, Gol. Whenever the State Health Society is called upon to do so.
