

1. That the GIA is sanctioned exclusively meant for Organisation of International Yoga Day on 21<sup>st</sup> June, 2021 under NHM during the financial year 2021-22.
2. That the Directorate shall not make any diversion of funds without approval from State Health Society and are to be utilized after observing all codal formalities required under rules and as per guidelines of MoH&FW, Gol.
3. That the separate saving bank account is to be operated for NHM funds and interest accrued thereon be refunded to the State Health Society.
4. ***That the Statement of Expenditure and Utilization Certificates are to be sent to the State Health Society immediately after completion of yoga event.***
5. That all the IEC supported under NHM should prominently carry NHM Logo in English, Hindi and regional languages.
6. That the proper record of Bank Column Cash Book, Ledger, Assets Register and other relevant records are to be maintained for inspection of any visiting team from Central/State Government.

7. That the accounts of the grantee/organization shall be open to the inspection by the sanctioning authority and audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI, whenever the grantee/Society is called upon to do so.
