In reference to this office communication No.SHS/NHM/J&K/PS/6257-67 & No. SHS/NHM/J&K/PS/6247-56 dated 5/7/2021 regarding the subject cited above and as per the additional administartive approval for ECRP for FY 2020-21 conveyed by the Ministry of Health & Family Welfare, Govt. of India under "India COVID-19 Emergency Response and Health System Strengthening Preparedness Package" sanction is hereby accorded to release of Grants-in-Aid Rs.437.87 Lac (Rupees Four Crore Thirty Seven Lac Eighty Seven Thousand only) in favour of Chief Engineer, Mechanical Engineering Department, Jammu division and Rs.371.00 Lac (Rupees Three Crore Seveny One Lac only) in favour of Chief Engineer, Mechanical Engineering Department, Kashmir division as 50% of projected cost in the DPRs for Civil Works, MGPS/Three Phase Power Sub-Station & Power Back Up.in order to installation & commissioning of PSA Oxygen Generation Plants approved under PM Care Fund at various health facilities mentioned in the above referred communications.

Further, remaining funds shall be released only after receipt of Utilization Certificate in form GFR 12C of actual expenditure incurred alongwith physical achievements under budget heads (FMR Code: B.31.3)

Accordingly, the above sanctioned GIA is hereby transferred into the official Bank A/c No.0077010200000146 of the Chief Engineer, Mechanical Engineering Department, Jammu and into Bank A/c No.0005010100005109 of the Chief Engineer, Mechanical Engineering Department, Kashmir through PFMS portal/e- transfer.

The Grants-in-Aid is sanctioned subject to the following conditions:-

- That the sanctioned funds are to be utilized exclusively for Civil Works, MGPS/Three
 Phase Power Sub- Station & Power Back Up for installation & commissioning of PSA
 Oxygen Generation Plants approved under PM Care Fund at health facilities and after
 observing all formalities required under rules and guidelines of ECRP-I issued by
 MoH&FW, Gol.
 - That the work shall be executed strictly as per the estimates/drawings/Plan technically approved by the competent authority.
- 3. That the Administrative Approval/Technical sanction of the work is obtained from the competent authority before execution of work and booking of expenditure.

- 4. That the work shall be restricted and completed within the administratively approved cost and there shall be no repetition of work.
- 5. That no diversion /re-appropriation of funds shall be made without approval of competent authority.
- That all the Infrastructure/ Equipment supported under COVID-19 (NHM) should prominently carry the NHM/PM Care fund/COVID-19 Logo in English, Hindi and regional languages.
- That the funds shall be utilized after proper gap analysis and also ensure that there may not be duplication of similar activities from other source.
- That the proper record of Bank Column Cash Book, Ledger, Assets Register and other relevant records are to be maintained for inspection of any visiting team from Central/State Government.
- 9. That the accounts of grantee/organization shall be open to the inspection by the sanctioning authority and audit by the Comptroller and Auditor General of India under the provisions of CAG (DPC) Act 1971 and internal audit by Principal Accounts Officer of the Ministry of Health & Family Welfare, GoI, whenever the grantee/Society is called upon to do so.
