- That the monthly Statement of Expenditure and Utilization certificate are to be sent to the State Health Society regularly,

- 16. That the proper record of Bank Column Cash Book, Ledger, Assets Register and other relevant records are to be maintained for inspection of any visiting team from Central/State Government.
