Sub: Release of Grant-in-Aid under Base Flexi pool (JSSK) for the activities to be undertaken during the year 2012-13.

Sir,

As approved by the Chairman Executive Committee State Health Society, sanction is hereby accorded to the release of Grant-in-Aid of Rs.75.00 Lacs (Rupees Seventy Five Lacs only) as hump sum amount for implementation of "Janani Shishu Suraksha Karyakaram (JSSK) in Govt. Lal Ded Hospital Srinagar, in pursuance to Govt. order No.516-HME of 2011 dated 29-9-2011 issued regarding exemption of user charges and free entitlements to all Pregnant women delivering in Public Health Institution and sick neonates up to 30 days with zero out of pockets expenses under Janani Shishu Suraksha Karyakaram (JSSK).

Accordingly Rs.75.00 Lacs (Rupces Seventy Five Lacs only) are hereby electronically transferred to your Bank account no.SBG-9 of J&K Bank Ltd. Govt. Medice! College, Srinagar.

You are, therefore, requested to release the above sanctioned funds to Medical Superintendent, Govt. Lal Ded Hospital, Srinagar to utilize the funds for timely implementation of the Programme and the balance funds required, if any, (except free diet to Pregnant women and neonate which is already being provided by the hospital) during the current financial year 2012-13.

## The Grant-in-Aid is subject to the following conditions:

- Establishment of centralized Call Centre alongwith toll free number is a mandatory requirement for providing referral transport services to the pregnant women ad neonates and expression of interest for its establishment has already been issued by the Director Health Services, Kashmir
- 2. All purchase are to be made after observing all codal formalities required under rules.
- 3. Cash reimbursement to the beneficiaries for referral transport is not permissible.
- Full justification of referral and type of complication is recorded at tertiary centre. Referral in and referral out registered are to be maintained in the health facility.
- Proper record of drugs and consumables issued to beneficiary be maintained. The list
  of essential drugs specified by MOH&FW, Gol, and its availability is ensured at health
  facility. No Cash reimbursement is allowed.

6. That the funds sanctioned are utilized strictly as per the G.O. Order No. 516- HME of 2011 dated 29-09-2011.

7. Healthy diet to the pregnant women is provided as per permissibility under the close supervision of the head of the institution and proper record is maintained. No Cash

The health facility shall follow all the financial management system under NRHM and shall submit monthly statement of expenditure/ FMR. That the physical achievements are sent to State Health Society regularly.

The proper record of Cash, book ledgers complete address of bineficiaries and other relevant records is maintained for check of any visiting team from Central/State

The account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the ministry of Health & Family Welfare, Government of India, whenever the society is called
