3. That the Specialists hired are placed in position at FRUs only. In rare case of any dire need for placing any Specialists other than FRUs, prior permission from the State Health Society be obtained in such case with reasons and remarks.
4. That the work done of each of Specialist is sent to the State Health Society on monthly basis.
5. That the funds are utilized after observing all codal formalities required under Rules and guidelines of MOH&FW, GOI.
6. The monthly Statement of Expenditure and Utilization Certificates is sent to the SHS regularly.
7. The account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts officer of the Ministry of the Health and Family welfare, GOI. Whenever the society is called upon to do so.
