- 4. That the Physical activities like JSY, Institutional Deliveries, RKS meeting etc should be uploded in HMIS webportal http://nrhm-mis.nic.in which is the only source of authenticate data.
- 5. That the District Health Socities/Institutions shall ensure the display of JSSK slogans and other benefits under NRHM on hoardings at prominent places of their respective insitution
- 6. That the proper record of cash books, ledgers, Assets created complete address of beneficiaries and other relevant records are mainstined at all levels.
- 7. That the account of the District Health Society shall be opened for inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, Gol. Whenever the society is called upon to do so.
