Whenever the society is called upon to do so.
- 5. That the above sanctioned funds are immediately transferred to Block Medical Officers within 2 days through e-transfer under intimation to the State Health Society except in some cases where e- transfer facility is not available and ensure that funds are got released by BMOs to downwards.
