**The Grant-in-Aid is subject to following conditions:**

1. That the above GIA is exclusively for colour coding of ambulances under 'National Ambulance Services (NAS)' in Jammu Division as per the approved Rate Contract.
2. That the funds sanctioned are utilized strictly as per the guidelines issued by MoH&FW, Govt. of India from time to time and after observing all codal formalities required under rules.
3. That uniformity in terms of name, design and colour and some key conditionalities as provided by the MoH&FW, Govt. of India shall be strictly adhered to.
4. That the proper record of Cash Book, Ledger, Assets and other relevant record is maintained at all levels for check of any visiting team Central/ State Govt. team.
5. That monthly Statement of Expenditure (SoE) & UC shall be sent to the State Health Society regularly.
6. The account of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the ministry of Health & Family Welfare, Government of India, whenever the society is called upon to do so.
