 - 3. The Implementing Agencies shall follow all the financial management systems under NUHM and shall submit Utilization Certificates, FMRs/ SoEs and Statement of Fund Position showing unspent balances, funds released as Advances, Interest earned on
 - 4. The Statement of Expenditure (SoE) and Utilization Certificate (UC) is sent to State
 - 5. The remuncration of contractual staff may be paid, provided a provision for the same has
 - 6. All the assets/ facilities supported under NUHM should prominently carry NHM Logo
 - 7. All purchases required to be made shall be affected on valid & approved Rate Contra after observing all codal formalities required under the Rules.
