 That funds shall be utilized strictly in accordance with the activities approval under RoP 2013-14 after observing all codal formalities required under the Rules and according to



the Guidelines issued by IDSP, MOH&FW, GoI which are available on the website http://www.idsp.nic.in/.

2. That the GIA is Recurring in nature and the objective for which it is being released is as below:-

The project development objective is to improve the information available to the Government Health Services and Private Health Care providers on a set of high-priority diseases and risk factors, with a view to improve on the ground responses to such diseases and risk factors.

- 3. That a separate assets register for the programme is maintained under seal & signatures of the Head of the institution.
- 4. The state shall not make any changes in allocations or re-appropriations among different components /activities without approval of the, MoH & FW, GoI.
- 5. That the remuneration of contractual staff may be paid, provided a provision for the same had made in the State PIP and approved by the NPCC for the current financial year
- 6. That Monthly SoE and Utilization Certificate is sent to the SHS regularly.
- 7. That the account of the District Health Society shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Officer of the Ministry of the Health & Family Welfare, GoI whenever the Society is called upon to do so.
- 8. The terms & conditions mentioned in the order referred above shall be the part of the release order and implemented in Toto.
