- 1. - 2. That the preference should be given to clear the pending liabilities on account of payment of ASHAs incentive and honorarium to AYUSH staff etc under NHM.
- 3. That District Health Socities shall accept the funds on the portal of PFMS after confirming same from their bank accounts and subsquently release funds to blocks similarlyy on the said portal. Both the Districts and the Blocks shall strictly ensure timley filing of expenditure on the said portal.
- 4. That the FMR should be submitted in customized Tally ERP to State Health Society on regular basis.
- 5. That the Physical achivements are to be sent to State Health Society on regular basis.

- 6. That the list of JSY and JSSK beneficiaries will be provided to the State Health Society, NHM, J&K on monthly basis, which should be uploaded on the website <a href="www.jknrhm.com">www.jknrhm.com</a> under "Mandatory Disclosures".
- 7. That the Physical activities like JSY, Institutional Deliveries, RKS meeting etc should be uploded in HMIS webportal <a href="http://nrhm-mis.nic.in">http://nrhm-mis.nic.in</a> which is the only source of authenticate data.
- 8. That the District Health Socities/Institutions shall ensure the display of JSSK slogans and other benefits under NHM on hoardings at prominent places of their respective insitution.
- 9. That the proper record of Bank Column cash books, ledgers, Assets created complete address of beneficiaries and other relevant records are maintained at all levels.
- 10. That the account of the District Health Society shall be opened to inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI. Whenever the society is called upon to do so.
- 11. That the above sanctioned funds are immediately transferred to Block Medical Officers through e-transfer under intimation to the State Health Society, NHM, J&K.
