

1. That the sanctioned funds are exclusively meant for condcuting the 5 Days Training of ASHA Facilitators (including participating districts) in round-2 of Module VI & VII during the year 2015-16 under Mission Flexible Pool.



- 2. That the funds to be utilized strictly as per the *enclosed estimated budget sheet* for the said training and as per the guidelines issued by the MoH&FW, GoI after observing all codal formalities required under rules (*strictly no cash payments*).
- 3. That District Health Society shall accept the funds on the portal of PFMS after confirming same from their bank accounts and subsquently release funds to blocks similarly on the said portal. Both the District and the Blocks shall strictly ensure timley filing of expenditure on the PFMS portal.
- 4. That the FMR should be submitted in customized Tally ERP to State Health Society on regular basis
- 5. That the Financial/Physical achivements are to be sent to State Health Society on regular basis.
- 6. That the proper record of Bank Column Cash Books, Ledgers, Assets created complete address of beneficiaries and other relevant records are maintained at all levels
- 7. That the accounts of the District Health Societies shall be opened for inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI. Whenever the society is called upon to do so.
