That the District Health Societies shall accept the funds on the portal of PFMS after confirming same from their bank accounts and subsquently release funds to blocks similarly on the said portal. Both the Districts and the Blocks shall strictly ensure timley filing of expenditure on the

That the FMR should be submitted in customized Tally ERP to State Health Society on 6.

That the Physical / Financial achivements are to be sent to State Health Society on regular basis.

9. That the proper record of Bank Column cash books, ledgers, Assets created complete address of beneficiaries and other relevant records are maintained at all levels.
