In reference to above referred letter and as approved by the Chairman Executive Committee, State Health Society, NHM J&K, sanction is hereby accorded to the release of Grant-in-Aid of Rs.135.00 Lacs (Rupees One Crore Thirty Five Lac Only) and also authorize to utilize the savings under head Pulse Polio to carry out the Intenstive Pulse Polio National Immunization (IPPI-2016), which are slated on 17/1/2016 & 21/2/2016 during the year 2015-16 under NHM.

That the accounts of the grantee/District Health Society shall be opened to inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, Gol. Whenever the institution/society is called upon to
- That the above sanctioned funds are immediately transferred to the concerned District 6. Health Societies/ other implementing agencies within 2 days through e-transfer under intimation to the State Health Society, J&K.
