**Sub: Release of GIA for Intensive Pulse Polio Immunization (IPPI-2016) rounds under NHM during the year 2015-16**

Sir,

In reference to above referred letter and as approved by the Chairman Executive Committee, State Health Society, NHM J&K, sanction is hereby accorded to the release of Grant-in-Aid of **Rs.135.00 Lacs (Rupees One Crore Thirty Five Lac Only)** and also authorize to utilize the savings under head Pulse Polio to carry out the Intensive Pulse Polio National Immunization (IPPI-2016), which are slated on 17/1/2016 & 21/2/2016 during the year 2015-16 under NHM.

Accordingly, the above sanctioned GIA is transferred to your official **Bank A/C No. 04050187** of Jammu & Kashmir Bank Ltd, Nagrota, Jammu.

**The Grant-in-Aid released is subject to following conditions:**

1. That the above sanctioned GIA is exclusively meant for Intensive Pulse Polio National Immunization (IPPI-2016) which are slated on 17/1/2016 & 21/2/2016 during the year 2015-16 under NHM, strictly as per the guidelines issued by the MoH&FW, GoI after observing all codal formalities required under rules.
2. That all the payments/expenditure should be done strictly through Account Payee Cheques or e-transfer.
3. That the Statement of Expenditure along with physical achievement and Utilization Certificate in GFR 19A be sent to State Health Society within 7 (seven) days.
4. That the proper record of Bank Column Cash Books, Ledgers, Assets Register and other relevant records are to be maintained for check of any visiting team from Central/State Government.
5. That the accounts of the grantee/District Health Society shall be opened to inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI. Whenever the institution/society is called upon to do so.
6. **That the above sanctioned funds are immediately transferred to the concerned District Health Societies/ other implementing agencies within 2 days through e-transfer under intimation to the State Health Society, J&K.**
