Accordingly, the above sanctioned GIA is hereby electronically transferred to the official bank account of your District Health Societies through e-transfer.

The Grant-in-Aid released is subject to following conditions:

1. That the sanctioned funds are to be strictly as per the Budget Sheets for the financial year 2016-17, already provided to your office vide this office letter No.SHS/J&K/NHM/FMG/12244-12304 dated 29/10/2016 and as per the guidelines issued by the MoH&FW, GoI after observing all codal formalities required under rules.

2. That the preference is to be given to clear the pendency on account of salary of manpower hired under NHM, outsourced staff, Incentive to the Doctors working in difficult areas & the ASHAs and other core activities of Mission Flexible Pool and the Districts/ Blocks will ensure that no expenditure of current financial year 2016-17 shall be carried over to next financial year.
3. That all the DDOs are advised to release the Incentive to the Doctors working under NHM in difficult areas alongwith their remunerations as instructed vide this office letter No.SHS/NHM/J&K/24318-75 dated 23/03/2017.
4. That the District Health Societies shall accept the funds on the portal of PFMS after confirming the same from their bank accounts and subsequently release funds to blocks similarly on the said portal, and the Districts/Blocks to ensure that all the expenditure are to be filed on the PFMS portal upto 31st March, 2017.
5. That the District Health Societies are to ensure that ASHAs payments are to be made only through Direct Benefit Transfer (DBT) mode.
6. That the timely submission of Concurrent Audit Report & compliance to the observations raised in the Statutory Audit Report is to be done.
7. That the FMR should be submitted in customized Tally ERP to the State Health Society on regular basis.
8. That the Physical/Financial achievements are to be sent to the State Health Society on regular basis.
9. That the Physical activities like Institutional Deliveries, RKS meeting etc are to be uploaded in HMIS web portal <http://nrhm-mis.nic.in> which is the only source of authenticate data.
10. That the District Health Societies/Institutions shall ensure the display of JSY/JSSK slogans and other benefits under NHM on hoardings at prominent places of their respective institution.
11. That the proper record of Bank Column Cash Books, Ledgers, Assets created, complete address of beneficiaries and other relevant records are to be maintained at all levels strictly as per the financial guidelines by MoH&FW, GoI.
12. That the accounts of the District Health Societies/other institutions/organizations shall be open to inspection by the sanctioning authority and Audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI. Whenever the society is called upon to do so.
13. That the above sanctioned funds are to be immediately transferred to Block Medical Officers through e- transfer under intimation to the State Health Society, NHM, J&K.
