**Sub: Release of Grant-in-aid under Routine Immunization on account of Incentives to
ASHAs under NHM during the year 2016-17.**

Sir/Madam,

In reference to your office requisitions and sanction is hereby accorded to the release of Grant-in-Aid of **Rs. 34.30 Lacs (Rupees Thirty Four Lacs and Thirty Thousands only)** under Routine Immunization to clear the incentives of ASHAs upto ending 30th June, 2016 as per detail given below:-


Accordingly, the above sanctioned Grant-in-aid is hereby electronically transferred to the official bank accounts of District Health Societies through e-transfer.

The Grant-in-Aid released is subject to the following conditions:

1. That the sanctioned funds are to be utilized strictly to *clear Incentives of ASHAs upto 30th June, 2016*, as per the rates, terms & conditions contained in the Budget Sheet and as per the guidelines issued by the MoH&FW, GoI after observing all codal formalities required under rules.
2. That the funds released under head ASHAs Incentives cannot be utilized for any other activities under NHM.

3. That the District Health Societies shall accept the funds on the portal of PFMS after confirming same from their bank accounts and subsequently release the funds to blocks similarly on the said portal.
4. That the District Health Societies shall immediately release the funds further in favour of Blocks and ensure that all the blocks shall ensure maximum utilization of available funds, alongwith present release under respective heads by or before 30th June 2016, so as to enable the State Health Society to report maximum expenditures to the Ministry of Health & Family Welfare, Govt. of India for the 1st quarter of 2016-17.
5. *That the payments to ASHAs on account of Incentives to be made through Direct Benefit Transfer (DBT) mode through PFMS portal only as per the directions of the Ministry of Health & Family Welfare, GoI. It shall also be ensured that payment of ASHA incentives are not to be made by any other mode like e-transfer/ Account Payee Cheque, etc.*
6. That the timely submissions of Concurrent Audit Report & compliance to the observations raised in the Statutory Audit Report are to be done.
7. That the FMR should be submitted in customized Tally ERP to the State Health Society on regular basis.
8. That the Physical/Financial achievements are to be sent to the State Health Society on regular basis.
9. That the proper record of Bank Column Cash Books, Ledgers, Assets created complete address of beneficiaries and other relevant records are to be maintained at all levels.
10. That the accounts of the District Health Societies shall be open to inspection by the sanctioning authority and Audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI, whenever the society is called upon to do so.
11. That the above sanctioned funds are to be immediately transferred to Block Medical Officers through e-transfer under intimation to the State Health Society, NHM, J&K.
