Accordingly, the sanctioned Grant-in-aid is hereby electronically transferred to the official bank accounts of above mentioned District Health Societies through e-transfer.

The Grant-in-Aid released is subject to the following conditions:

That the sanctioned funds are to be utilized only for ASHAs incentives under NHM for the year 2016-17, strictly as per the same rates, terms & conditions contained in the Districts' Budget Sheet and as per the guidelines issued by the MoH&FW, GoI after observing all codal formalities required under rules.



- 2. That the payments to ASHAs on account of Incentives to be made through Direct Benefit Transfer (DBT) mode through PFMS portal only, as per the directions of the Ministry of Health & Family Welfare, Gol. It shall also be ensured that payment of ASHAs' incentives are not to be made by any other mode like e-transfer/ Account Payee Cheque, etc.
- 3. That the District Health Societies shall accept the funds on the portal of PFMS after confirming same from their bank accounts and subsequently release the funds to blocks similarly on the said portal.
- 4. That the funds released under head ASHAs' incentive cannot be utilized for any other activities under NHM.
- 5. That the timely submissions of Concurrent Audit Report & compliance to the observations raised in the Statutory Audit Report are to be done.
- 6. That the FMR should be submitted in customized Tally ERP to the State Health Society on regular basis.
- 7. That the Physical/Financial achievements are to be sent to the State Health Society on regular basis.
- 8. That the proper record of Bank Column Cash Books, Ledgers, Assets created, complete address of beneficiaries and other relevant records are to be maintained at all levels.
- 9. That the accounts of the District Health Societies shall be open to inspection by the sanctioning authority and Audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI, whenever the society is called upon to do so.
- 10. That the District Health Societies shall immediately release the funds further in favour of Blocks and ensure that all the blocks shall disburse the ASHA's incentive & remuneration of manpower hired under NHM upto ending August, 2016, and report expenditures under these heads to the State Health Society in the FMR ending August, 2016.
