That the Physical/Financial achievements are to be sent to the State Health Society on

regular basis.

That the proper record of Bank Column Cash Books, Ledgers, Assets created, complete address of beneficiaries and other relevant records are to be maintained at all levels strictly

as per the financial guidelines by MoH&FW, GoI.

That the accounts of the District Health Societies shall be open to inspection by the sanctioning authority and Audit by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, GoI. Whenever the society is called upon to do so.

through e- transfer under intimation to the State Health Society, NHM, J&K.
