## The Grant-in-Aid released is subject to the following conditions:

- 1. That the sanctioned funds are to be utilized strictly to clear the pending liabilities on account of remuneration of manpower hired under NHM upto 30th June, 2016, as per the same rates, terms & conditions contained in the Budget Sheet and as per the guidelines issued by the MoH&FW, GoI after observing all codal formalities required under rules.
- 2. That the funds released under head remuneration cannot be utilized for any other activities
- 3. That the District Health Societies shall immediately release the funds further in favour of concerned office and ensure that maximum utilization of available funds can be done, alongwith present release under respective heads by or before 30th June 2016, so as to enable the State Health Society to report maximum expenditures to the Ministry of Health & Family Welfare, Govt. of India for the 1st quarter of 2016-17.

4. That the District Health Societies shall accept the funds on the portal of PFMS after confirming same from their bank accounts and subsequently release the funds to blocks similarly on the said portal.

5. That the timely submissions of Concurrent Audit Report & compliance to the observations

raised in the Statutory Audit Report are to be done.
