TERMS AND CONDITIONS:

1. Candidate should be permanent resident of J&K State.
2. Candidate should have excellent communication and presentation skills in English and local language, and must be conversant with computers especially in MS Office, etc.
3. Candidate should have familiarity with socio-cultural and socio-economic conditions of the State.
4. Candidate should be dedicated, hardworking and willing for extensive touring across the State.
5. In addition to concerned District, candidate may opt for two additional Districts where he/she is willing to serve. Selection of candidate will be as per the District-wise merit out of eligible candidates. However, in case of non-availability of suitable eligible candidate from the concerned District, State Health Society will consider the candidate on the basis of merit cum preference opted by him/ her.
6. Merit of candidates, who have obtained degrees from Foreign Universities having grading system, shall be calculated on the pattern of Jammu & Kashmir Public Service Commission.
7. Hiring will be purely on contractual basis. Initial contract for hiring shall be **upto 31st March 2018**, and further yearly extension will be subject to satisfactory performance of the candidate/ approval of the post by the Ministry of Health & Family Welfare, Govt. of India.
