- 4. Candidate should be dedicated, hardworking and willing for extensive touring across the State.
- 5. In addition to concerned District, candidate may opt for two additional Districts where he/she is willing to serve. Selection of candidate will be as per the District-wise merit out of eligible candidates. However, in case of non-availability of suitable eligible candidate from the concerned District, State Health Society will consider the candidate on the basis of merit cum preference opted by him/her.
