SUPERVISORY REPORT

In compliance to your Order No.177of 2015 dated 05-02-2015, the team comprising of State Finance Manager, Assistant Programme Manager Trainings and Assistant Programme Manager Child Health, State Health Society, J&K visited district Doda, Kishtwar, Ramban, Udhampur and Reasi. The following observations found during the supportive supervision is as under:-

Date: 09-02-2015

DISTRICT DODA

Trainings:-

- ➤ On the day of visit the 1st day NSSK training was being conducted at District Hospital Doda. The total of 28 participants has attended the training. The participants who attended the training have been nominated from delivery points and potential delivery points. The training was inaugurated by the Chief Medical Officer, Doda. The banner was displayed in the training. The training material and other stationary required were being provided for the training. The doll, ambu bag and towels were also available for demonstration.
- ➤ It was observed 2 trainers were available for delivering the lecture. The quality of presentation was good but one of the trainers was not audible properly.
- ➤ The tea/lunch was provided to the participants. On having discussion with the Chief Medical Officer regarding the non-conduction of IMNCI training, is due to non-availability of trainer.
- > During the supervision of the training in the district hospital, team also made supervisory visit in the district hospital with the Medical Superintendent.

- ➤ The drugs available in the hospital under JSSK are available.
- ➤ Blood bank is functional but not registered.
- > HIV screening of patients is being done.
- ➤ On interaction with the attendants of beneficiary, the service made to them was satisfactory.
- Total number of deliveries performed during last month was 156 in which normal were 122 and c-section 34.
- ➤ Colour coded dustbins was in place but were not maintained properly according to bio medical waste norms.
- ➤ The JSY and JSSK hoardings were displayed outside the hospitals also.
- ➤ It was found beneficiaries were given free diet, medicines and transportation and data were maintained in registers.

Newborn Care:-

- ➤ NBCC was functional at District Hospital.
- Two Radiant Warmer were placed in the NBCC.
- ➤ SNCU was functional at District Hospital and at the time of monitoring four newborns were put on radiant warmers, it was found that twins were placed in single radiant warmer. The area of SNCU was not clean properly. Till date 130 newborns were admitted in SNCU,the equipment's placed in SNCU are: 5 Radiant Warmers, 2 pulse oxmeters, 2 suction units,1 insect killer,1 weighing machine,1 needle cutter
- ➤ Colour coded dustbins was placed in the waiting area of SNCU.
- ➤ Inj.Vit K, Mucus extractor and bag mask available in the hospital.
- > Clean towels available.

Child Health:-

- ➤ Vitamin A,ORS ,syp salbutamol,syp Albendazole was available in the institution.
- > Zinc was not available in the hospital.
- ➤ Vaccines (BCG, OPV, Hep B, Pentavalent vaccine) were available in the District Hospital.

Adolescent Health:-

- ➤ The ARSH counselor is in place and it was observed 3-4 cases of adolescence is being counseled per day. On interaction with her, she had not visited any schools / outreach activities. It was also observed that her room is not adjacent to Gyane OPD. She was asked to attend the Gynae OPD, and also make rounds in postpartam wards to counsel the beneficiaries.
- ➤ Dicyclomine, Weekly Iron folic acid supplementation tablets and Albendazole were available in the hospital

Other Observations:-

- ➤ DEIC was established in District Hospital and proper manpower has been given but because of diversion of funds to core activities, the play area, physiotherapy equipment's, medicine etc. were missing and till now only three surgeries have been done which are: cleft lip, ENT cyst and club foot, there are around eight surgical cases registered which are pending. The drugs under RBSK are also not available in the hospital.
- ➤ The identification of ASHA grievance redressel cell was being identified in the premises of district hospital.
- The ASHA Greh was placed and functional.

Trainings:

➤ The DHS, Doda has conducted the Trainings of ASHA Facilitators in round-II of Module VI & VII and NSSK Training of MOs/ANMs/SNs/LHVs during the year, against which no red accounts has been made. Whereas, the funds for Trainings of ASHAs in round-I of Module VI-VII has been further released to Blocks for trainings.

Releases:

- ➤ The funds released by the State Health Society to the DHS, Doda during the current financial year 2014-15 (upto ending Jan, 2015) under RCH Flexible pool, Mission Flexible, Immunization and other activities are tallied and further released to Blocks/Implementing agencies.
- An amount of Rs.15.23Lac has been released by the Director, Health Services; Jammu on 10/1/2015 for the procurement of drugs & supplies under child health & RBSK programme, but the funds actually has not been transferred into the bank account of District Health Society till date.

Expenditures:

- An amount of Rs.1,28,000/- has been paid to M/s Legno Furniture, Marble Market, Jammu vide Ch.No.214054 dated 1/7/2014, for the purchase of furniture for the

- DIEC unit without bill, requisition of concerned section, codal formalities and entries in the Fixed Asset Register.
- ➤ An amount of Rs. 4,20,000/- has been paid to M/s Salman & Usman, Doda vide Ch.No.214055 dated 1/7/2014, on account of hiring of vehicles for RBSK teams without Bill and physical achievement report of RBSK teams. Moreover, tendering process file not provided to verify the procedure on the basis which rates of hiring the vehicles for RBSK teams were finalized. Also, no TDS has been deducted from the firm while making the all the payments of hiring of vehicles during the year, which is mandatory under Income Tax Act. In this regard, strict instruction has been passed.

- ➤ All the consumable items procured during the year are not entered in the concerned stock register.
- ➤ Reply to Statutory Auditor's observations for the year 2013-14 is pending.
- ➤ Concurrent Audit Report of 3rd qtr 2014-15 is pending.
- ➤ Reply to observations raised by the Concurrent Auditor in 1st & 2nd qtr of 2014-15 is pending.

District Hospital Doda:-

- ➤ The Cash Book of JSY/JSSK/RKS have been maintained and duly signed by the Medical Superintendent upto ending Dec 2014.
- ➤ JSY payment register has been maintained up to ending Dec,2014 and 3 beneficiary have been called up telephonically for the cross verification, reply was satisfactorily.
- ➤ The Bank Account of JSY Account is not reconciled. There is difference of Rs.6,87,600/- between the bank balance as per Cash Book & Bank Statement, it needs to be reconciled. As such, a time bound strict instruction has been given to the District Hospital Account Manager for reconciliation.

- ➤ TDS is not being deducted on the payment of salary to manpower engaged under NHM and other services providers like diet, housekeeping etc.
- ➤ Fixed Asset Register has not been maintained in accordance with the prescribed format of MoH&FW, GoI.
- ➤ No ledgers, Cheque Issued Register, Advance Register are being maintained.
