# Sub: Tour Report of Dr. Arshid Nazir, Assistant Programme Manager, Maternal Health, NHM J&K.

In compliance to order no. 27 of 2015 dated 06-05-2015, undersigned accompanied by District Monitoring & Evaluation Officer, Rajouri and District RMNCH+A Coordinator visited blocks of district Rajouri w.e.f. 07<sup>th</sup> May to 09<sup>th</sup> May, 2015 to get the feedback on the quality of trainings of Swasthya slate & its functioning thereof and to do supportive supervision of facilities visited as per the order:-

## Block Sunderbani & Block Nowshera:-

## **Training of Swasthya Slate:-**

In Block Sunderbani, 6 ANMs were interviewed & in block Nowshera 4 ANMs were interviewed regarding functioning of Swasthya Slate on 7<sup>th</sup> May, 2015. Following observations were made while interviewing the ANMs:

- 1. Inventory of Swasthya Slates is not being maintained by BMO office, as the Swasthya Slates have been issued to ANMs directly by the PHFI without involvement of CMO/BMO.
- 2. Details of ANMs trained in functioning of Swasthya Slate has not been shared with BMO/CMO office.
- 3. In block Sunderbani, ANMs interviewed are well trained and confident in operating Swasthya Slate. However, ANMs of Nowshera block are still hesitating and need more handholding by field coordinator.
- 4. It was informed by the ANMs and also observed during skill test that most of the times there is variation in recording of Haemoglobin, BP & Blood Sugar. Sometimes it shows more & sometimes lesser values than actual values as recorded by conventional methods.
- 5. In block Sunderbani, ANMs informed that the basic & essential test of Haemoglobin is not working on Swasthya Slate. Same has been also discussed during training, but till date it has not been sorted.
- 6. Similarly, tests like ECG, Respiratory Rate, Sthethoscope use, Foetal Doppler use, Height & weight measurement, Serum Cholesterol & Prothrombin test have not been shown and practiced during training. As a result these tests are not being done at present by using Swasthya Slate.

- 7. It was also reported by the ANMs & seen by the monitoring team that Hepatitis-B test result does not appear in preview even after it is being done & saved. Similarly, in another interface Blood Group/ HIV/ & Hep. B results are not shown when reports are generated.
- 8. ANMs wanted this training for longer duration so that they have a complete understanding in working and use of Swasthya Slate, since they were not able to do the test on their own in these two days training schedule.

CHC Sunderbani is the FRU functioning in govt. building having round the clock facility of electricity & water, and is easily accessible by road. Post of Anaesthetist is vacant at CHC Sunderbani.

• Blood Storage Unit is established but currently non-functional due to some technical fault with refrigerator. During 2014-15, three units of blood has been given to beneficiaries.

#### 3. JSY:

• JSY benefits are being given through A/C Payee Cheque only. However, JSY beneficiary list is not displayed at CHC, but is available with BAM Sunderbani & is submitted on monthly basis to DAM/ DMEO, Rajouri.

#### 4. JSSK:

All the entitlements available under JSSK are given to mothers & infants.
 Free drugs and consumables; free diagnostics, free diet & free referral transport services are being provided to beneficiaries & proper record is maintained in register.

#### 5. MDR:

During FY 2014-15, one maternal death namely Ms. Champa Devi W/O
Puran Chand R/O Ambh Khori, Sunderbani has been reported from the
block. Death has occurred at SMGS Hospital and verbal autopsy has been
done by the team constituted by BMO, Sunderbani.

- 4. **Skills of staff nurses** posted in Labour Room are lacking in providing essential newborn care & essential Intra-partum care to newborns & mothers respectively.

- 1. ORS, Tab. Albendazole, Zinc Suplhate Tabs. and Vitamin A are available at CHC Sunderbani.
- 2. Syrup Salbutamol and Salbutamol nebulising solutions are also available at CHC Sunderbani.
- 3. All the vaccines are available & stored in cold chain as per the protocols. However, daily charting of ILR/ DF temperature is not being recorded.

## **Block Manjakote & Block Darhal:-**

## **Training of Swasthya Slate:-**

On day 2, two blocks were visited – block Manjakote & block Darhal. In Block Manjakote, 4 ANMs were interviewed & in block Darhal, 5 ANMs were interviewed regarding functioning of Swasthya Slate. Following observations were made while interviewing the ANMs:

- 1. Inventory of Swasthya Slates is not being maintained by BMO office, as the Swasthya Slates have been issued to ANMs directly by the PHFI without involvement of CMO/BMO.
- 2. All the ANMs have been trained in both the blocks in a batch of 55-60. However, BMO does not have any details of ANMs who were given Swasthya Slate. List of trainees & those provided with Swasthya Slate has not been shared by PHFI.
- 3. ANMs in both the blocks demand re-orientation on Swasthya Slate in smaller groups of 10-12 for better understanding of its functionality.
- 4. It was informed by the ANMs and also observed during skill test that most of the times there is variation in recording of Haemoglobin, BP & Blood Sugar. Sometimes it shows more & sometimes lesser values than actual values as recorded by conventional methods.

- 5. In block Darhal, ANMs informed that the basic & essential test of Haemoglobin is not working on Swasthya Slate due to some technical fault which has been reported to field coordinator.
- 6. Under ANC, details of LMP is not getting captured.
- 7. ANMs wanted this training for longer duration so that they have a complete understanding in working and use of Swasthya Slate, since they were not able to do the test on their own in these two days training schedule.

On day 3, ANMs of two blocks were interviewed – 4 from block Kandi & 6 from block Darhal regarding functioning of Swasthya Slate. Major findings are as follows:

- 1. Inventory of Swasthya Slates is not being maintained by BMO office, as the Swasthya Slates have been issued to ANMs directly by the PHFI without involvement of CMO/BMO.
- 2. All the ANMs have been trained in both the blocks in a batch of 55-60. However, BMO does not have any details of ANMs who were given Swasthya Slate. List of trainees & those provided with Swasthya Slate has not been shared by PHFI.
- 3. ANMs in both the blocks demand re-orientation on Swasthya Slate in smaller groups of 10-12 for better understanding of its functionality.
- 4. ANMs wanted this training for longer duration so that they have a complete understanding in working and use of Swasthya Slate, since they were not able to do the test on their own in these two days training schedule.
- 5. It was informed by the ANMs and also observed during skill test that most of the times there is variation in recording of Haemoglobin, BP & Blood Sugar. Sometimes it shows more & sometimes lesser values than actual values as recorded by conventional methods.
- 6. One ANM, Ms. Rita Devi from Subcentre Potha block Kalakote, informed that her Hb value by Sahli's method done one day before training session was reported as 8 gm%, however during training session, her Hb value using Swasthya Slate was shown as 14 gm%, which clearly shows that there are serious quality issues with the Kit.
- 7. In block Kalakote, user ID & passwords have not been provided to ANMs. Training in Kalakote was conducted on 27<sup>th</sup> & 28<sup>th</sup> April, 2015. As a result, they are unable to log in, even for entering ANC details of beneficiary.
- 8. During training, only demo has been given by PHFI trainers. No handholding of ANMs has been done.
