

Subject: Tour report of DrAadil Bashir Assistant Programme Manager (ASHA), NHM, J&K

In compliance to your order no.27of 2015 dated 06-05-2015, i had visited District Doda accompanied with District Programme Manager and District RMNCH+A Coordinator where i visited Block Assar Block Gandoh Block Thatri Block Ghat and Block Baderwah to verify the quality of training on Swasthya slate and did supportive supervision of Block Assar Block Gandoh and Block Baderwah, the observations during the visit are follows:-

Date:-07-05-2015

District Doda Block Assar:

Training of Swasthya Slate:-

On the day of Visiti have interacted with six ANMs and following are the observations related to the quality of Swasthya slate training:

- ➤ Trainers of Swasthya Slate from PHFI have given training to ANMs/FMPHW nurses for two days from 5/05/2015 to 06/05/2015.
- Quality of training according to BMO was good
- ➤ During interaction with ANMs I have found ANMs are not fully trained and they require more orientation related to Swasthya Slate.
- ➤ 16 ANMs have received the Swasthya slate kits according to report provided by Block
- > ANMs have received the Swasthya slate kits through PHFI.
- > ANMs have not conducted any test on Swasthya slate till now.
- > ANMs have received all he accessories of Swasthya slate.
- > During interaction most of the ANMs said they require more training.
- > Sim-card for the tablets provided to ANMs is not activated yet.
- ANMs have been provide lunch during the training of Swasthya Slate, PHFI trainers have took the Account numbers of ANMs to credit their TA into their accounts.
- ANMs have been given training of 13 tests in first stage which they can conduct on Swasthya slate e.g. BP,BloodSugar,Temperature,HB,

- Pregnancytest ,Malaria test ,HIV,Hepatitis B, Blood Grouping ,Pulse oximeter ,Syphilis.
- > PHC have not maintained inventory of Swasthya Slate kits, reason being kits have been provided through PHFI.

- 1. OCP, EC pills and IUCD 380 A are available at the PHC
- 2. Condoms, Tab.Mifepristone and Misoprostol are available at the facility.
- 3. Family planning counseling is being done at the facility.

Maternal Health

- 1. The labor room was not muchclean, and there was no delivery taking place during the visit.
- 2. The labor room protocols were displayed inside the labor room.
- 3. Inj Oxytocin, emergency tray, Antibiotics were available at the facility.
- 4. The diet under JSSK was being provided to the beneficiaries.
- 5. The drugs under JSSK are available at the facility.
- 6. There was no patient admitted during the visit.
- 7. Normal deliveries only being conducted at the PHC Assar.
- 8. JSY entitlements are being provided to the beneficiaries.

- 9. A/C payee checks are being provided to the JSY beneficiaries
- 10. Total number of deliveries performed during last month was 13 in which normal were 13 and C-section are nil.
- 11. Color coded dustbins are not available at the facility.
- 12.IEC material are available at the facility JSSK, RBSK Hoarding are displayed outside the facility.
- 13. Free transports are being provided to the JSSK beneficiaries.

Newborn Care

- 1. NBCC was functional at the facility.
- 2. One Radiant Warmer was placed in the NBCC.
- 3. There was not any new born patient on radiant warmer during the visit.

Child Health

- 1. Vitamin A,ORS, sypsalbutamol,sypAlbendazolewas not available at the facility.
- 2. Zinc was not available in the PHC.
- 3. Vaccines are available at the facility.

Adolescent Health

Iron folic acid supplementation tablets and Albendazole tablets are not available at the facility.

ANM is performing normal deliveries at the facility, she is SBA trained. The ASHA Greh was placed but during the visit there was not any ASHA present, block ASHA coordinator was present during the visit when i asked her regarding 34 ASHA incentives she was not fully aware about these incentives.

District Doda Block Gandoh:-

Training of Swasthya Slate:-

On the day of Visit I have interacted with four ANMs and following are the observations related to the quality of Swasthya slate training:-

- > Training was provided by PHFI trainers
- > Quality of training according to concern BMO was very good.
- \triangleright Training was given for two days (05/05/2015 To 06/05/2015).
- According to ANMs they have been given training of 13 tests like, BP, Blood sugar, HB Value, HIV, Hepatitis B, Syphilis, Blood grouping, SPO2 etc.
- > ANMs have not conducted any test on Swasthya slate yet; they will be conducting tests from Monday onwards.
- > ANMs require more training to operate Swasthya slate perfectly.
- > During interaction i found some of the tests like BP, HB is showing variations in reading.
- Swasthya Slate Kits have been provided through PHFI not from BMO and Block have not maintained inventory of Swasthya Slate kits.
- > ANM MsNazia of CHC Gandoh when conducted test on Swasthya slate, but reading of HB value was not accurate it showed 21.5. Same was with Blood pressure it also showed inaccurate reading.
- > According to report provided by block 12 ANMs have received Swasthya . slate kits with consumables.
- > ANMs have been provided lunch during the training session, and PHFI trainers have collected their account numbers for TA.

- 9. Total number of deliveries performed during last month is 30 in which normal were 30 and C-section 0.because normal deliveries only being performed at the facility because of non-availability of gynecologist.
- 10.Iron Folic Acid tablets are available at the facility they have purchased it from untied funds
- 9. Color coded dustbins was in place.
- 10. During visit in labor room one baby was on radiant warmer
- 11. Labor room register are being maintained at the facility.
- 12. Emergency trays were available in the labor room.
- 13. Racks for sleepers were available outside the labor room.
- 14. Duty Roaster displayed outside the labor room.

Newborn Care

- 1. NBCC was functional at the .CHC
- 2. One Radiant Warmer were placed in the NBCC.
- 3. Inj. Vit.K, Mucus extractor, Bag ,Masks were available at the CHC
- 4. Towels for receiving new born were available in the labor room.
- 5. Sterile cord cutting equipment were available in the labor room
- 6. SNCU were established at the CHC, equipment's were in place but was not functional.
- 7. NBSU is functional at the CHC.
- 8. NBCC register are being maintained at the CHC.

- 2. Facility has not provided line listing of severely anemic pregnant women's and they have not provided any incentive for attending home delivery by SBA.

Training of SwasthyaSlate

On the day of Visit i have interacted with six ANMs and following are the observations and findings related to the quality of Swasthya slate training:-

- > According to BMO quality of training was very good
- > During interaction with ANMs i found they are not fully trained and some of the ANMs were unable to operate tablets.
- ➤ 28 ANMs have been provided Swasthya slate training out of which 23 have received Swasthya slate kits in which 9 are from regular side and 14 are from NHM side.
- ➤ Pulse oxymeter of two ANMs was not functioning.
- ➤ During interaction most of the ANMs said they require more training to use Swasthya slate kit easily.
- ➤ ANMs have not conducted any test on pregnant women's by Swasthya slate kit yet.
- ➤ ANM have conducted HB and BP test on me and it showed huge variations on reading.
- ANMs have been provided lunch by PHFI during two days training and PHFI employees has taken their account numbers for TA.
- ANMs have been given training of 12 tests in first stage like, HB, Blood Pressure, Blood Sugar, SPO2, HIV, Syphilis, Blood urea, etc.

Training of SwasthyaSlate

On the day of Visit i have interacted with Ten ANMs and following are the observations and findings related to the quality of Swasthya slate training

- ➤ 54 ANMs have attended training on Swasthya slate out of which 27 ANMs have received Swasthya slate kits in which 26 are from NHM side and one from regular side.
- ➤ ANMs require more training on Swasthya slate.
- > During interaction with ANMs some of the tests like BP and HB are not showing accurate reading.
- > ANM MsShaistaParveen of sub centreMalwas have not received consumables.
- ➤ ANMs have attended two days training from 05/05/2015 To 06/05/2015.
- ANMs have received Swasthya slate kit through PHFI not from BMO.
- > Inventory of Swasthya slate are not being maintained by block.
- > ANMs have not examined any pregnant women through Swasthya slate till now.

District Doda Block Baderwah

Training of SwasthyaSlate

On the day of Visit i have interacted with eleven ANMs and following are the observations and findings related to the quality of Swasthya slate training:-

- ➤ 45 ANMs have received Swasthya slate training out of which 23 have received Swasthya slate kits in which 5 ANMS are from regular side and 18 are from NHM side.
- > Swasthya slate kits are being provided through PHFI and not from BMO.
- > Inventory of Swasthya slate are not being maintained by Block.
- > During interaction with ANMs they require more training on Swasthya slate. Some of the functions of tablet were not functioning properly like population.
- ANMs have been provided two days training on 05/05 2015 To 06/05/2015, and ANMs have not started doing tests on Swasthya slate till date.
- ANMs have been provided lunch through PHFI during the training and PHFI has taken their account numbers for TA.

- 2. Zinc was not available at the facility.
- 3. BCG, OPV, Hep B, DPT, Measles, SypVit A, Pentavalent vaccine.
