In reference to above mentioned communication and as per the approval of Executive Committee, State Health Society, NHM, J&K, sanction is hereby accorded to release of Grant-in-Aid of **Rs.2,31,320/- (Rupees Two Lac Thirty One Thousand Three Hundred Twenty only)** under RCH Flexible Pool on account of Honorarium of Law Officer hired under NHM for the financial year 2019-20, working at Directorate of Health Services Kashmir.

1. That the sanctioned GIA is exclusively meant for the honorarium of Law Officer hired under NHM for the year 2019-20 and working at Directorate of Health Services Kashmir, remuneration may be released after appraising their performance.
2. That the Directorate shall accept the funds on PFMS portal after confirming the same from its bank account and subsequently release funds to the employees immediately through the said portal/e-transfer under intimation to the State Health Society, NHM, J&K and also upload the expenditure on the same portal regularly.
3. That the funds are to be strictly utilized after observing all formalities required under rules and guidelines of MoH&FW, GoI.
4. That the Statement of Expenditure and Utilization certificate are to be sent to the State Health Society regularly.
5. That the physical achievements in terms of numbers of legal cases handled during the period are to be sent to the State Health Society regularly.
6. That the proper record of Bank Column Cash Books, Ledgers, Assets Register and other relevant records is maintained so that same is checked by any visiting team from Central/State Government.
7. That the accounts of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the ministry of Health & Family Welfare, Government of India, whenever the grantee is called upon to do so.
