
Accordingly, the above sanctioned GIA is hereby electronically transferred to your official bank account.





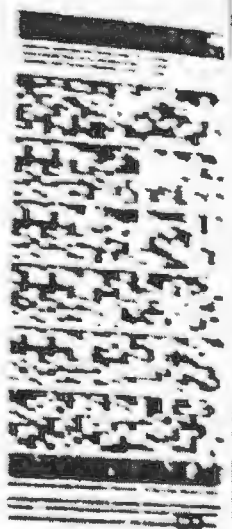
