- 1. That the above sanctioned GIA is exclusively meant for the disbursement of Rent of NHM, J&K Office of Kashmir under RCH Flexible pool during the year 2017-18, and utilized strictly as per the guidelines issued by the MoH&FW, GoI and after observing all codal formalities required under rules.
- 2. That the payment of rent is to be made strictly as per the terms and conditions of Rent Agreement.
- 3. That the proper record of Bank Column Cash Book, Ledger, Assets and other relevant record are to be maintained for inspection of any visiting team Central/State Govt.
- 4. That the replies of the observations of Statutory Auditor are to be done.
- 5. That the monthly Statement of Expenditure and Utilisation Certificates are to be sent to the State Health Society regularly.
- 6. That the accounts of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal Audit by Principal Accounts Office of the Ministry of Health & Family Welfare, Government of India, whenever the society is called upon to do so.
