- That the Directorate shall accept the funds on PFMS portal after confirming the same from their bank accounts and subsequently release funds to the respective institution immediately through the same portal/ e- transfer under intimation to the State Health Society, NHM, J&K. Further, ensure that all the expenditure are to be uploaded on PFMS portal.

That as per the directions of GoI & Aadhaar Act, 2016, Aadhaar Number being mandatory to receive any social benefits. The institution shall ensure 100% Aadhaar seeding of all Contractual Staff engaged

under NHM.

That the monthly Statement of Expenditure and Utilization Certificate are to be sent to the State Health Society regularly.

That the proper record of Bank Column Cash Books, Ledgers, Assets Register and other relevant records is maintained for check of any visiting team from Central/State Government.

That the accounts of the grantee shall be open to the inspection by the sanctioning authority and Audit both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by Principal Accounts Office of the ministry of Health & Family Welfare, Government of India, whenever the grantee is called upon to do so.
