## Corrigendum cum Addendum

In response to the queries of intended bidder(s), during the pre-bid meeting held on 13<sup>th</sup> March 2021 with respect to this office NIT No.: 07 of 2020, published vide No.: SHS/NHM/J&K/Estt./20443-50 dated: 13/02/2021, for "Establishment of Integrated 104 - Centralized Call Center cum Health Helpline in Jammu & Kashmir on Build-Operate-Transfer (BOT) basis", read with Corrigendum-cum-Addendum issued vide No.: SHS/NHM/J&K/Estt./4663 dated: 22/03/2021, following(s) amendment(s) shall henceforth form integral part of said NIT:

- (1.) **Eligibility Criteria:** Existing **Sub-Clause (i) of Clause (2)** of the SBD, read with the Corrigendum-cum-Addendum issued, is hereby '**Replaced**' with following:
  - The bidding entity, including its Directors/ Members/ Sister Concern(s)/ Associated Company(ies), should not have been found guilty/ convicted by any Competent Court of India, or De-recognized/ Blacklisted by any Govt. Institution of the Country, for offences involving moral turpitude/ corruption in relation to its business dealings with the Govt., or any other Public Sector Enterprises, as well as for matter(s) relating to the Security & Integrity of the Country.
  - In case, as on date of bidding, any action or suit or proceeding or investigation is lying pending against the bidding entity, or its Directors/ Members/ Sister Concern(s)/ Associated Company(ies), at Law or in equity before any Court or before any other Judicial, Quasi-Judicial or other Investigation/ Regulatory authority, for offences involving moral turpitude/ corruption in relation to its business dealings with the Govt., or any other Public Sector Enterprises, as well as for matter(s) relating to the Security & Integrity of the Country, the outcome of which may constitute an event of default or impair the operations of the Project in J&K in any manner whatsoever, detail(s) of all pending litigation(s)/ any investigation(s) inter-alia name of Investigating Agency, Charge(s)/ Offense(s) for which investigation(s) was/ were launched, date since pending, present status and all other relevant information should have to be disclosed.
  - Further, in such case(s), intended bidder(s) shall also have to submit an affidavit to the effect that pending outcome of the action or suit or proceeding or investigation, as the case may be, if any such bidder will be declared successful and accordingly awarded the Contract after finalization of the bidding process, it shall undertake to indemnify the State Health Society, NHM, J&K, through irrevocable Bank Guarantee equivalent to 100% CAPEX cost or 50% of Total OPEX cost, whichever is lower. This additional Bank Guarantee will be over & above the Performance Security Guarantee stipulated under clause (9) of the Standard Bid Document (SBD), and shall remain in force till completion of pending action or suit or proceeding or investigation against bidding entity/ its Directors/ Members/ Sister Concern(s)/ Associated Company(ies), or completion of the Contract Period, whichever is earlier.
  - Furthermore, in case bidding entity/ its Directors/ Members/ Sister Concern(s)/ Associated Company(ies), will subsequently held guilty/ convicted in such case(s), State Health Society NHM J&K, in addition to other recourses available to it inter-alia forfeiture of EMD/ normal Performance Bank Guarantee submitted in reference to clause (9), recommendation(s) for debarring/ black-listing, etc., reserves the exclusive right to forfeit this Bank Guarantee, after taking into consideration all the relevant facts inter-alia gravity of offence, nature & implications of conviction, etc. and the same shall be without any further recourse in favour of bidding entity
- (2.) **Bid Preparation and Submission:** Existing **Sub-Clause 3(a) of Clause 3(A)** of the SBD, read with the Corrigendum-cum-Addendum issued, is hereby '**Replaced**' with following: Intended bidder(s), and in case where bid is submitted by a Consortium each member(s) of the Consortium, are required to furnish an affidavit, on Non-Judicial Stamp Paper of Rs.100/-, duly attested by **01**<sup>st</sup> **Class Judicial Magistrate** to the effect that:

- a) Bidding entity, including its Directors/ Members/ Sister Concern(s)/ Associated Company(ies), has not been found guilty/ convicted by any Competent Court of India, or de-recognized/ blacklisted by any Govt. Institution of the Country, for offences involving moral turpitude/ corruption in relation to its business dealings with the Govt., or any other Public Sector Enterprises, as well as for matters relating to the Security & Integrity of the Country.
- b) There is no action or suit or proceeding or investigation pending against the bidding entity, or its Directors/ Members/ Sister Concern(s)/ Associated Company(ies), at Law or in equity before any Court or before any other Judicial, Quasi-Judicial or other Investigation/ Regulatory authority, for offences involving moral turpitude in relation to its business dealings with the Govt., or any other Public Sector Enterprises, as well as for matter(s) relating to the Security & Integrity of the Country, the outcome of which may constitute an event of default or impair the operations of the Project in J&K in any manner whatsoever; and
- c) If anything is found wrong at any stage, bidding entity, and its authorized representative, shall be responsible and deem to any legal action against it by the State Health Society, in addition to other recourses inter-alia forfeiture of EMD/ normal Performance Bank Guarantee submitted in reference to clause (9), recommendation(s) for debarring/ black-listing, etc.

In case any of the intended bidder(s) is/ are unable to furnish requisite affidavit, as per (b)(ii) supra, it shall have to submit –

- a) An affidavit stating detail(s) of all pending litigation(s)/ any investigation(s) pending against bidding entity, or its Director(s)/ Member(s)/ Sister Concern(s), inter-alia name of Investigating Agency, Charge(s)/ Offense(s) for which investigation(s) was/ were launched, date since pending, present status and all other relevant information in the matter;
- b) An affidavit to the effect that pending outcome of the action or suit or proceeding or investigation, as the case may be, if any such bidder will be declared successful and accordingly awarded the Contract after finalization of the bidding process, it shall undertake to indemnify the State Health Society, NHM, J&K, through irrevocable Bank Guarantee, equivalent to 100% CAPEX cost or 50% of Total OPEX cost whichever is lower, as required vide clause 2(i) of the SBD and
- c) If anything is found wrong at any stage, bidding entity, and its authorized representative, shall be responsible and deem to any legal action against it by the State Health Society, in addition to other recourses inter-alia forfeiture of EMD/ normal Performance Bank Guarantee submitted in reference to clause (9), recommendation(s) for debarring/ black-listing, etc.

## (3.) No. of MIS application(s) of MoH&FW, Govt. of India to be integrated with the Call Centre:

- a) Presently, Call Centre will have to be integrated with RCH application/ portal maintained by the MoH&FW, Govt. of India through NIC. However, during continuation of Contract Period, it may require to be integrated with various other portals/ applications viz., HMIS, HWC, SNCU, RBSK, PFMS, e-Raktkosh, IHIP, ICMR, HRMIS, PC&PNDT and so Exact no. of such poral(s)/ application(s) can not be exactly apprehended beforehand.
- b) Accordingly, intended bidder(s), are ADVISED to quote price for "Cost of development, management & integration of Application Programming Interface (APIs) for seamless data transfer between call centre software and MIS portals of the MoH&FW, Govt. of India" on per "API" basis, so as to enable National Health Mission/ Health & Medical Education Deptt., J&K to increase the No. of APIs to be integrated, as & when required, during the contract period.
