- 1. The appointment is purely contractual in nature initially upto 31st March 2023 which may be further renewed based upon the performance of the candidate and approval of the post by the Ministry of Family & Family Welfare, Govt. of India, in the SPIP of NHM for the FY2023-24. However, in case of unsatisfactory performance, the Mission Director, NHM, J&K, on recommendations of the Chief Medical Officer may terminate the services of the candidate.
- 2. The contractual appointment shall not confer any right on the appointee to claim extension or for regular appointment at any point of time.
- 3. The candidate shall have to give one month notice before leaving the contractual services and if the candidate fails to do so, in that case one month remuneration of such candidate shall be forfeited.
- 4. The candidate shall be paid an honorarium as per the programme guidelines of CPHC which shall be enhanced as per the yearly approval in RoP from MoHFW, Gol under NHM.
- 5. The candidate shall have to join his/ her duty within seven days from the date of issuance of this order positively along with all requisite original documents for verification by the Chief Medical Officer.
