## Corrigendum cum Addendum

In response to the queries of intended bidder(s), during pre-bid meeting held on 17<sup>th</sup> July 2021 with respect to this office Tender Notice No(s): 02(A)/ (B) of 2021, published vide No.: SHS/NHM/J&K/RBSK/704-08 dated: 06/07/2021, for “District-wise Rate Contract for hiring of vehicle(s), on monthly basis, for Mobile Health Team(s) under Rashtriya Bal Swasthya Karyakaram (RBSK) for medical blocks of respective District(s) in Jammu/ Kashmir Division(s)”, after threadbare discussions and as recommended by the Committee, following(s) amendment(s) shall henceforth form integral part of the Standard Bid Document (SBD):

- (1.) **Rates will be inclusive of fuel cost, lubricants, spare parts, maintenance, salary of driver, payment of insurance, road tax, etc. required for operation of vehicle(s) in J&K.**
- (2.) Sub-clause (b) of clause (1) – ‘Scope of Work’, stipulated condition “Rates are to be quoted on per Month basis only for ‘Medium’ segment including Tavera/ Scorpio/ Xylo/ Bolero, etc.” shall now be read as “**Indicative category of vehicle(s) required for Mobile Health Team(s) may include either Tata Sumo/ Winger, Chevrolet Tavera, Mahindra Bolero/ Xylo/ Scorpio or Maruti – Omni/ Eeco only. Accordingly, rates can be quoted, on Per Month basis, keeping in view the make of vehicle(s) available/ prevalent in respective District(s)**”. Rates quoted for any other make shall not be accepted/ entertained.
- (3.) With respect to the concern(s) raised by intended participant(s) regarding indicative monthly usage 2860 Kms per month per vehicle, as per sub-clause (c) of clause (1) – ‘Scope of Work’, vis-à-vis maximum ceiling of Rs.35,000/- (Rupees Thirty-Five Thousand only) per vehicle per month (inclusive of all taxes, etc.) per vehicle per month, as prescribed by the Ministry of Health & Family Welfare, Govt. of India, as per sub-clause (d) of clause (1) – ‘Scope of Work’, it is for consideration of all the intended participant(s) that this is purely an indicative maximum usage of vehicle(s) for requisite activity(ies), calculated on the basis of indicative daily duty hours of 11 hours, with 2 hours break, subject to maximum of 110 Kms for 26 working days, as per Passenger Fare Revision (2021) issued by the Transport Commissioner & Chairman, State Transport Authority, J&K vide notification No.: 01P-MVD of 2021 dated: 19/03/2021, during any particular month and in view of any exigency. **Actual utilization of vehicle(s) shall be as per ‘Scope of Work’ mentioned in the SBD.**
- (4.) Sub-clause (j) of clause (1) – ‘Scope of Work’, stipulated condition “Vehicle(s) to be provided should not be older than three (3) years, but in any case, not later than five (5) years” shall now be read as “**Vehicle(s) to be provided should not be older than 2012 make. In addition, bidder(s), including the successful bidder(s), shall have to ensure roadworthiness of the vehicle(s) to be provided to Mobile Health Team(s),**

**which shall not only be always in good running condition, but also contain valid vehicle fitness certificate, duly issued by the Competent Authority, at all times during the Contract period, failing which Contract may be terminated without according any further opportunity**". Accordingly, sub-clause (g) of clause 9 – 'Responsibilities of Successful Bidder', stands modified and shall now be read in light of this amendment.

- (5.) Sub-clause (c) of clause (8) – 'Terms of Payment', existing clause "Payment shall be made by the State Health Society, NHM, J&K on monthly basis", shall now be substituted with **"Payment shall be made by the concerned Block Medical Officer(s) on monthly basis"**. This amendment has been incorporated with the objective of minimizing the lead time in payment of bill(s), submitted alongwith requisite report(s)/ certification(s) verified by the concerned Officer(s)/ Mobile Health Team(s). In case of any repeated occurrence(s) of unusual delay in payment of bill(s), concerned service provider shall bring the matter to the notice of Tender Inviting Authority for appropriate necessary action, as deemed appropriate in the matter.
- (6.) Sub-point (e) regarding Registration No. issued by the Deptt. of Tourism/ Transport, J&K, under Point No. (1.) of Annexure 'C' – Particulars of Bidder hereby stands **'Deleted'**.
- (7.) With respect to Annexure 'D', there is no stipulation as to minimum, or otherwise, No. of vehicle(s) available with bidder(s), as on date of bidding, for intended services. Needless to mention here that these detail(s) will substantiate the soundness and capability(ies) of intended participant(s) towards providing requisite services, which otherwise would be difficult to establish. Accordingly, it is discretionary on part of the intended participant(s) to decide, and accordingly provide the detail(s) of vehicle(s) available with them for requisite services(s). It has to be ensured that the details provided shall be correct, complete and alongwith requisite substantiating documents, failing which these details shall not be considered as true & correct. In order to reduce the file size, as raised by some of the participants, documents can be scanned at 100 DPI.
- (8.)
