Section – I: Scope of Work

- 1. Security Audit of ASHA Gullak application of NHM J&K developed by the NIC J&K, hosted on NIC Server and accessible through link: https://ashagullak.jk.gov.in. Installation of auditing/ testing tools, if any, for the audit purpose will be the responsibility of auditor(s). State Health Society NHM or NIC J&K will not be providing any tools for the purpose.
- 2. Application has to be audited to discover any vulnerabilities/ weaknesses and prioritization of various risks to this application. Application has to be audited as per CERT-in Standards and Open Web Application Security Project (OWASP) guideline, and in conformity with NIC audit guidelines.
- 3. Typical issues which need to be discovered may include improper input validation, insecure direct object reference, invalidated directs and forwards, Cross-Site Scripting (XSS), Cross-Site Request Forgery (CSRF), Broken Authentication and Session Management e.g. weak passwords, weak session management, various injection flaws e.g. SQL Injection, Command Injection etc., Security Mis-Configurations well-known Platform and Component Vulnerabilities, Sensitive Data Exposure, Missing or Improper Access Control, Forceful Browsing, Form/ Hidden Field Manipulation, Insecure Use of Cryptography, Cookie Posing, Errors Triggering Sensitive Information, Leak etc.
- 4. Auditor will have to undertake user profiling and suggest specific access methodologies and privileges for each category of users identified in each web application.
- 5. Auditors will have to carry out an assessment of vulnerabilities, threats and risks that exist in this web application through Internet Vulnerability Assessment and Penetration Testing. This will include identifying remedial solutions and recommendations for implementations of the same to mitigate all identified risks, with the objective of enhancing the security of the system.
- 6. During security audit, if any lapse is found, same shall be reported to the State Health Society, NHM, J&K. As the application is already hosted on NIC Server, counter measures on security risk, vulnerabilities and recommended corrective actions, if required, will be undertaken by State Health Society NHM J&K through NIC J&K to make the application fully secured.
- 7. Auditor shall submit the final audit report after the remedies/ recommendations are implemented and confirmed with retest. And hence, re-assessment/ testing may be required.
- 8. Auditor will have to provide all requisite support to resolve any issue(s), if raised by NIC before accepting the Audit Certificate, in co-ordination with State Health Society NHM.

- 1. After Testing/Re-testing, auditor shall have to submit the following(s)
 - a. An observation report describing discovered vulnerabilities, weaknesses, misconfigurations with recommended actions for risk mitigation
 - b. 'Audit Certificate', alongwith all documentations, etc. for the application as per NIC norms stating that the application is safe for hosting on NIC Server.
 - c. In addition to the Audit Certificate, as per (b) supra, Audit Report shall include, but not limited to the following(s):

Section - IV: Eligibility Criteria

- 1. Intended Participant(s), before submitting proposal(s), shall ensure compliance to following 'Eligibility' criteria, failing which their proposal(s) are liable to be Rejected Outrightly:
 - a. shall be currently empaneled with CERT-In for Information Security Audit (s). List of currently empaneled auditing organization is annexed with this RFP.
 - b. must have executed minimum Ten (10) projects related to Application Security Audit in any Govt. (Central/ State/ UT) Organization/ PSU(s) in India. Work Order(s) alongwith completion certificate(s) shall have to be submitted.
 - c. including its Proprietor/ Partner(s)/ Director(s)/ Member(s), has not been found guilty/ convicted by any Competent Court of India, or de-recognized/ blacklisted by any Govt. Institution of the Country, for offences involving moral turpitude/ corruption in relation to its business dealings with the Govt., or any other Public Sector Enterprises, as well as for matters relating to the Security & Integrity of the Country. Self-Declaration to this effect, on Letterhead, shall have to be submitted.
 - d. shall be having valid PAN and filing ITR(s) on regular basis. Copy of PAN alongwith copy(ies) of Income Tax Return(s) for the financial year(s) 2018-19, 2019-20 and 2020-21 shall have to be submitted.
 - e. shall be having valid GSTN and filing GST Return on regular basis. Copy of GST Certificate alongwith latest GSTR 3B shall have to be submitted.

Section- V: Submission & Evaluation of Proposal(s) and Award of Contract (AoC):

1. Submission of RFP:

Intended Participant(s), fulfilling above-mentioned Eligibility Criteria, are required to submit their Proposal(s) in response to this office RFP, and as per requirements envisaged in the Scope of Work, as follows -

- a) Self-assessed Checklist (**Annexure I**), duly signed by the Authorized Signatory, towards compliance of eligibility criteria. If it is established that any of the participant(s) have submitted false/ mis-leading information towards its eligibility, State Health Society, NHM, J&K, besides rejecting the candidature of such participant, will also black-list such participant(s) from participating in future projects of NHM in J&K for a period of three (3) years.
- b) Authorization letter, issued by the Competent Authority, authorizing 'Authorized Signatory' to submit RFP and make communications with State Health Society, NHM, J&K in reference to instant Request for Proposal. It shall be ensured that only such Person be 'Authorized' who shall have the capacity to bind the Participating Organization, for e.g., Proprietor himself, or any Partner authorized by all other Partner(s)/ any Managerial Personnel authorized by the Board in this behalf.
- c) Detailed proposal, alongwith **Minimum Indicative Time** required for completion of Security Audit of web application. No deviation from the proposal once submitted will be permitted during the Contract Period, except which will be required in exigency and after seeking approval from the Competent Authority of Procuring Entity.

d) Financial Proposal, as per Annexure - IV.

e) Conditional Proposal(s) are liable to be 'Rejected' outrightly.

2. Modification/ Substitution/ Withdrawal of Proposal(s)

Proposal(s) once submitted (uploaded), are not allowed to be modified, substituted or withdrawn by participant(s). Therefore, it is emphasized upon all the intended participant(s) that all terms & conditions of RFP should be carefully studied for successful submission of complete and comprehensive proposal. Failing to comply with any of the terms & conditions will only lead to rejection of proposal, even if it is the most competitive offer.

3. Evaluation of RFP and Award of Contract (AoC)

In view of exigency, financial proposal(s) of 'Eligible' proposal(s), supported with all the substantiating documents, shall be considered, and Contract will be awarded on following basis:

- a. Eligible participant quoting the 'Lowest', i.e., L-1 Rate.
- b. In case of 'Tie' between L-1 Rate(s), Contract will be Awarded to the Participant offering minimum lead time for completion of security audit of web application.
- c. Similarly, in case of 'Tie' between minimum lead time for completion of security audit of web application, Contract will be awarded to the participant which have executed Highest No. of similar IT security audit projects for Central/ State/ UT Govts./ PSUs during previous five (5) years.

Section-VI: Validity of Rates and Terms of Payment

- 1. Rate(s) coming into force after finalization of this RFP shall remain non-negotiable and fixed during the currency of Contract.
- 2. Approved agency shall have to maintain the confidentiality of the application as well as audit findings and ensure that these findings are to be shared with State Health Society, NHM and NIC J&K only. It has to execute Non-Disclosure Agreement with State Health Society, NHM, J&K.
- 3. Approved agency/ organization shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this Contract to any other Service Provider/ Firm/ Company/ Agency, even if it is CERT-in empaneled agency/ organization for security audit purpose.
- 4. 100% payment will be made after completion of security audit and receipt of Final Security Audit Certificate, after deduction of Statutory dues/ levies, as applicable. Invoice shall have to eb verified by the Nodal Officer, as well as supported by NIC clearance/ acceptance.
- 5. Approved agency/ organization shall have to submit invoice in 'Triplicate' alongwith all documentation, inter-alia Audit Certificate, Audit Report, etc.
- 6. No advance payment(s), of any sort, shall be made by this office.
- 7. In case of any failure on part of the approved agency to complete the security audit in stipulated time, or backing out of the Contract, it shall be liable for the difference of amount which State Health Society, NHM, J&K may have to incur at higher rates than the rates contracted with approved agency. This will be in addition to other penal action(s) which this office may initiate against approved agency.

Section-VII: General Terms & Conditions

- 1. Intended participant(s), meeting the eligibility criteria, shall prepare and submit proposal(s) strictly in accordance with the terms & conditions set forth in this RFP by the last date and time for submission of same. Proposal(s) submitted in any other manner will not be accepted.
- 2. All the document(s) should be valid at the time of uploading of proposal(s), and not be expiring till submission of proposal(s) in response to RFP.
- 3. Intended participant(s), requiring any clarification regarding this EoI, may submit queries/ suggestions if any, on e-mail ID: facaonhmjk@gmail.com, by or before ogth April 2022 after which no query(ies) shall be entertained.
- 4. Participant(s) are expected to examine carefully the contents of this RFP. Failure to comply with the requirements of this RFP will be at participants' own risk and make the proposal(s) non-responsive.
- 5. Participant (s) shall provide all the information sought under this RFP. Tendering Committee will evaluate only such proposal(s) which will found to be complete in all respects. Incomplete and/ or conditional proposals may be liable for rejection outrightly.
